Situation

Stockton on Tees forms part of the Tees Valley conurbation being situated at the junction of the regions principal highways the A66 & A19 which in turn connect into the A1(M) close to Darlington.

The A66 is one of the areas main highways connecting Middlesbrough (4 miles), Stockton & Darlington (10miles).

Description

The premises comprise a detached unit of steel portal frame construction with brick and block walls with profile cladding above and to the roof. The front of the premises has glazed panels and there are roller doors to the rear leading to a gated yard.

Previously used as a showroom the premises are square with suspended ceiling and lighting with an eaves height of 3.75m rising to 4.5m at the apex.

Accommodation

We calculate that the premises provide the following approximate gross internal areas.

Externally dedicated parking and storage in an enclosed yard.
